Dear Mr. Belza:

Boyce Reynolds, Service Manager accompanied me during Ohio EPA's January 27, 2009 and February 4, 2009 inspection of Toyota Direct's facility in Columbus, Ohio. I inspected Toyota Direct to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC).

We found the following violation of Ohio's hazardous waste laws:

- **OAC Rule 3745-273-14, Labeling standards for small quantity handlers of universal waste:** A small quantity handler of universal waste must label or mark the universal waste batteries clearly with any of the following phrases: "Universal Waste-Battery(ies)," or "Waste Battery(ies)," or "Used Battery (ies)." Toyota Direct failed to label or mark universal waste batteries as required by this rule. During the inspection, Toyota Direct properly labeled universal waste batteries which were being accumulated on-site.

Toyota Direct, located at 4248 Morse Road, Gahanna, Ohio was previously named Performance Toyota. Performance Toyota notified as a Small Quantity Generator of hazardous waste in June, 1995.

Toyota Direct was inspected on January 27, 2009, and February 4, 2009. Currently, Toyota Direct is not a generator of hazardous waste.

Boyce Reynolds, Service Manager provided information about site activity, waste generated, and off-site management of that waste; as follows:

Used Oil: About 300 gallons of used oil are generated weekly at the service department. The used oil is accumulated in a 500 gallon tank located adjacent to the service building. This tank is provided with secondary containment should a leak occur. The tank is labeled "used oil", as required. Universal Environmental Services, Florence Ky. transports the used oil off-site for reclamation.

Oil filters: Oil filters are drained prior to being placed into a tote which is transported by Universal Environmental Services, Florence Ky. for recycling.

UW lamps: Lamps are accumulated on-site until they are picked up for recycling by USA Lamp&Ballast.

Scrap metal including rotor grindings: Rotor grindings, along with scrap metal, are picked up and transported off-site for recycling by G COR Automotive Corporation.

Antifreeze: Universal Environmental Services, Florence, Ky. transports the antifreeze off-site for recycling.

Batteries: Interstate batteries picks up UW batteries when new batteries are delivered weekly.

Tires: Scrap tires are accumulated outside and are recycled through Liberty Tire Service of Ohio, Grove City.

I provided guidance documents for each of the waste streams, as appropriate. I explained the requirement to properly evaluate waste and most frequent violations discovered. I explained the difference between used oil and waste oil. I talked about cleaning up residue when a UW lamp breaks and employee training. I pointed out on-line the DHWM website, the answer place, rules, guidance, and checklists.

Next door to Toyota Direct is Direct Collision. I suggested that Boyce share the website and checklists with them since they are part of the same organization. I offered to do a courtesy visit if they called me. They said what about right now; so I did a walk through the adjacent site located at 4040 Appian Way. At this location cars are prepared for painting and painting repairs prior to actually being painted.
