Dear Mr. Holmes:

On October 6, 2010, a Compliance Evaluation Inspection (CEI) was conducted at the Honeywell Ironton Facility. The purpose of the inspection was to determine Honeywell's compliance with its NPDES Permit. Present for the inspection were Pat Holmes representing OMI, Honeywell's contractor, and Stephen Wells representing Ohio EPA, Division of Surface Water, Southeast District Office. No wastewater samples were collected as part of the inspection. A copy of my inspection report is attached.

As a result of my inspection, I have the following comments:

1. Outfall 001 was observed at the sampling location. The discharge appeared to be clean.
2. The former production area had additional wells put into operation as part of the clean-up of the facility. The wastewater treatment plant has adequate capacity to handle the additional flow.
3. One of the tanks used for storm water runoff flow has been taken out of service due to the condition of the tank. The removal of this tank has no effect on the operation of the wastewater treatment system.
4. The site is doing the analysis for pH on-site. The calibration, maintenance, and record-keeping of the pH meter was observed and appeared adequate at the time of the inspection.






