On June 10, 2011, I conducted a Compliance Evaluation Inspection at the Lumi Lite Candle Co., Inc. located in Norwich, Ohio. On June 3, 2011, I reviewed your DMR's and other records with Mr. Mike Wisecarver of Wisecarver Environmental. The purpose of the inspection was to determine Lumi-Lite's compliance with NPDES Permit Number OGS00045*BG and the Ohio Water Pollution Control Act, Revised Code Chapter 6111.


As a result of the inspection and review of our files, the facility appears to be in compliance with its' NPDES permit. No apparent violations were found at the time of inspection.




