On August 20, 2010, I conducted a Compliance Evaluation Inspection at the Malta WTP located in Malta, Ohio. You and Damon Drake represented Malta and accompanied me during the inspection. The purpose of the inspection was to determine Malta's compliance with NPDES Permit Number 01Z00031\*CD and the Ohio Water Pollution Control Act, Revised Code Chapter 6111.

As a result of the inspection and review of our files, I found no apparent violations.

Attached is a copy of the inspection report. Malta should take the appropriate actions to maintain the facility in compliance with all terms and conditions of the NPDES permit.

The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For those wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. 
