On February 16, 2011, I conducted a Compliance Evaluation Inspection at Portsmouth Regional Airport located in Portsmouth, Ohio. Ryan Smith represented Scioto County and accompanied me during the inspection. The purpose of the inspection was to determine Scioto County's compliance with NPDES Permit Number OPG00059\*DD and the Ohio Water Pollution Control Act, Revised Code Chapter 6111.

As a result of the inspection and review of our files, I found no apparent violations.

Attached is a copy of the inspection report and indicates the areas evaluated during the inspection. Scioto County should take the appropriate actions to maintain the facility in compliance with all terms and conditions of its NPDES permit.

The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For those wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. 
