Based on this documentation, Mercy Fairfield has adequately demonstrated abatement of the following violations discovered during the December 2, 2008, inspection:

- 3. **Waste management – standards for small quantity handlers of universal waste, OAC 3745-273-13(D)(1)**
- 4. **Labeling/marking – standards for small quantity handlers of universal waste, OAC 3745-273-14(A) and (E)**
