RE: Complaint Investigation

On March 24, 2011, Ohio EPA's Division of Hazardous Waste Management (DHWM) conducted an investigation at Yeager's Automotive 1, LLC (Yeager's Automotive) at 7984 Cin-Dayton Road West Chester, Ohio. This investigation was conducted in response to a complaint received at our office concerning mismanagement of automotive fluids. The purpose of the investigation was to determine whether violations of Ohio's hazardous waste laws exist at this property.

Ohio EPA did not verify the existence of any mismanagement of fluids during the inspection. However, Ohio EPA did observe that a tank and several containers used to collect used oil were not properly labeled.

Based on these observations Yeager's Automotive is in violation of the following hazardous waste laws:

1. **OAC 3745-279-22 (B)(1):** Used oil storage requirements for generators: Containers and aboveground tanks used to store used oil at generators facilities must be labeled or marked clearly with the words "Used Oil".

Yeager's failed to comply with this regulation in that used oil an aboveground tank outside and several containers inside used to collect used oil did not have the words "Used Oil" on them.

To return compliance Yeager's Automotive must label the aboveground tanks and any other containers used to collect used oil with the words "Used Oil" as required by this rule. **Please submit information to this office by May 2, 2011 documenting compliance with this regulation.**

General Comment

During the investigation Yeager's Automotive had a few questions concerning the installation of several more tanks for storage of used oil. Please find attached a copy of "Understanding the Spill Prevention Control and Countermeasure (SPCC) Requirements" fact sheet. This fact sheet will help you determine any reporting

requirements you may have under the SPCC regulations with the addition of used oil tanks.

**USED OIL INSPECTION CHECKLIST
GENERATORS, COLLECTION CENTERS AND AGGREGATION POINTS**

NOTE: 1. A facility is subject to the federal SPCC regulations (40 CFR 112) if it is non-transportation related (e.g., fixed) and has an aggregate above ground storage capacity greater than 1,320 gallons or a total underground storage capacity greater than 42,000 gallons of oil (including used oil), and there is reasonable expectation of a discharge to navigable waters.

2. Inspectors can check BUSTR's web-site at https://www.comapps.ohio.gov/sfm/fire_apps/bust/bustr/PublicInquiry.asp to determine if a UST containing used oil is registered with BUSTR. Inspectors may call BUSTR at 614-752-7938 or a BUSTR site coordinator to report an unregistered UST or a UST that appears to not be in compliance with BUSTR regulations.
