Dear Mr. Harnett:

On February 27, 2008, I completed a review of the financial assurance documentation on file for the ESAB Welding and Cutting Products' (ESAB) Ashtabula facility referenced above. I evaluated the facility for compliance with post-closure requirements set forth in the Ohio Administrative Code (OAC) rules 3745-66-44 and 3745-66-45.

To demonstrate compliance with post-closure, ESAB uses a Letter of Credit (LOC) with a Standby Trust Agreement. The most recent financial assurance documentation received by the Ohio EPA included: 1) LOC No. DCSLDI712590 issued by HSBC Bank PLC on September 18, 2003 in the amount of \$450,575.00. 2) A Standby Trust Agreement with Wachovia Bank and Trust NA, dated March 15, 1990. 3) A post-closure cost estimate dated June 25, 2006 detailing annual costs of \$15,910.00.

Upon review of the financial assurance documentation, the following violation was found.

Ohio Administrative Code 3745-66-44


The OAC 3745-44-(E)(1) states that a copy of the facility's current, detailed post-closure cost estimate prepared and maintained in accordance with OAC rules 3745-44-(A) and (B) must be submitted annually to the director of the Ohio EPA. The annual post-closure costs have not been updated since June 25, 2006. Please update them for inflation and submit this to me in writing.
