Dear Mr. Long:

On June 13, 2007, I completed a review of the financial assurance documentation on file for the International Steel Group, Inc.'s (ISG) facilities referenced above. I evaluated the facilities for compliance with financial assurance and liability requirements set forth in the Ohio Administrative Code (OAC) rules 3745-55-42 through 3745-55-51.

In a March 30, 2007 letter, you asked for an extension of time to submit documentation for a financial test. The reason given for the request was that ISG, Ispat Inland, Inc. and Acelor had recently merged causing a delay in financial reporting. You stated that although Mittal expected to file its 2006 financial report by April 15, 2007, additional time was needed to complete the independent auditor's report. You asked for 30 additional days to submit financial documentation.

On March 30, 2007, Brent Smith of Burgess & Niple, Inc. submitted updated closure and post-closure cost estimates for your two facilities. As of the date of this letter, OEPA has not received any additional financial assurance documentation.

Upon review of the financial assurance documentation, the following violations of Ohio Administrative Code (OAC) were found:

Mittal has failed to submit financial assurance for closure and post-closure, in violation of OAC 3745-55-43 and OAC 3745-55-45; and

Mittal has failed to provide liability coverage in violation of, OAC 3745-55-47.


