Dear Ms. Connell:

On April 30, 2007, I completed a review of the financial assurance documentation on file for the Parker Hannifin Corporation (PHC) facility referenced above. I evaluated the Waverly facility for compliance with post-closure requirements as set forth in Ohio Administrative Code (OAC) rules 3745-55-44, 3745-55-45, 3745-66-44 and 3745-66-45.

On September 27, 2006, PHC submitted documentation to demonstrate compliance with the financial assurance requirements. A financial test was submitted which included the 2006 Annual Report to Shareholders, an independent auditor's report and a post-closure cost estimate.

Upon review of the financial assurance documentation, the following violations were found:

OAC 3745-55-44(A) and (B): The owner or operator of a disposal surface impoundment, disposal miscellaneous unit, land treatment unit, or landfill unit, or of a surface impoundment or waste pile required under rules 3745-56-28 and 3745-56-58 of the Administrative Code to prepare a contingent closure and post-closure plan, must have a detailed written estimate, in current dollars, of the annual cost of post-closure monitoring and maintenance of the facility in accordance with the applicable post-closure requirements in rules 3745-55-17 to 3745-55-20, 3745-56-28, 3745-56-58, 3745-56-80, 3745-57-10, and 3745-57-93 of the Administrative Code.

PHC's post-closure cost estimate does not meet the requirement of a detailed post-closure cost estimate. The estimate is not in current dollars nor has it been updated for inflation. PHC's post-closure cost estimate may not be calculated as the present value of money using a discount rate.
