On June 4, 2010, I completed a review of the financial assurance documentation file for the 9150 Group, LLC's (9150) facility referenced above. I evaluated the facility for compliance with financial assurance and liability requirements set forth in the Ohio Administrative Code (OAC) rules 3745-55-42, 3745-55-43 and 3745-55-47.

In addition I evaluated the facility for compliance with the financial assurance requirements set forth in the Consent Order, State of Ohio V. 9150 Group, LLC, et al., Case No. 2006-07-4740, Summit County Court of Common Pleas, dated March 22, 2010.

To demonstrate compliance with financial assurance and liability rules, Aerosol Systems, Inc. uses a Trust Fund administered by J. P. Morgan (Account # 10216280.2) established August 7, 1990. The value of the trust, as of April 30, 2010, was \$247,270.53. No other current financial documentation for the above referenced facility has been received by the Ohio EPA.

Paragraph 23 of the March 22, 2010 consent order requires 9150 to immediately submit a detailed closure cost estimate upon approval of a new closure plan or within 30 days of approval of concurrent modification of closure plan(s) in compliance with OAC 3734-55-42.

Paragraph 24 of the March 22, 2010 consent order requires 9150 to submit documentation of financial assurance for closure within 15 days of approval of the closure plan(s) 9150 in compliance with OAC 3734-55-43.

Paragraph 25 of the March 22, 2010 consent order requires 9150 to submit documentation of third party liability coverage in compliance with OAC 3734-55-47.
