Dear Mr. Yoder:

On March 2, 2009, the Division of Hazardous Waste Management (DHWM) electronically received the 2008 Hazardous Waste Annual Reports for the ProVia Door facilities in Sugar creek and Walnut Creek. You are listed as the certifier of the reports for these facilities in both 2007 and 2008. Scott Widmer is the Authorized Representative who signed the Electronic Data Submittal Memorandum of Agreement (PIN Application form) that DHWM received from the Sugar creek facility on March 14, 2005 and from the Walnut Creek facility on February 19, 2004. Mr. Widmer is the only individual who can certify ProVia's Reports with the assigned PIN in accordance with the Agreement, which is based on Ohio Administrative Code rule 3745-50-42. Because the certifier of the 2007 and 2008 reports is not the same individual who filed the Agreement, these ProVia Door facilities are in violation of 3745-50-42(C), Changes to Authorization.

To abate these violations, the DWHW asks for a letter from your supervisor explaining that you are authorized to submit these reports, and that you certify that the information contained in them is complete and accurate according to the certification statement that can be found on both the Annual Report Site ID form and the PIN application. Your letter should contain your original signature for our records. Normally we would ask you to submit a new PIN Application form, but we expect to implement the use of Ohio EPA's eBusiness Center for our reporting and PIN management for the 2009 report due in March, 2010.
