Dear Mr. Green:

On February 28, 2007, the Division of Hazardous Waste Management received a 2006 Hazardous Waste Annual Report (HWAR) from Toxco as well as a replacement for the 2005 HWAR. The 2005 report replacement was submitted in response to a Notice of Violation dated January 11, 2007, in which Toxco was cited in violation of OAC rule 3745-54-75 because Waste Receipt forms were not included in the original report.

Please note that receipts from customers in a foreign country should be identified with the letters "FC" in the first two characters of the EPA ID number field. This is mentioned in the Special Instructions of the HWAR booklet under "Wastes Shipped to or received from foreign countries" and in US EPA's Biennial Report instructions <http://www.epa.gov/epaoswer/hazwaste/data/br05/05report.pdf>. The data validations will not produce a fatal error for the state code when the ID begins with FC regardless of what you enter as the state. We have changed the customer ID on WR page 19 (2005 report) and WR page 21 (2006 report) to "FCUWHANDLERS."
