Dear Mr. Cottrell:

On May 12, 2007, I completed a review of the financial assurance documentation file for Environmental Recycling, Inc.'s (ERI) facility referenced above. I evaluated your facility for compliance with financial assurance and liability requirements set forth in the Ohio Administrative Code (OAC) rules 3745-55-42, 3745-55-43 and 3745-55-47.

On December 7, 2004, ERI became a permitted TSD by rule. As a permitted facility, ERI is required to maintain financial assurance for closure and liability coverage. ERI has been contacted several times about this requirement but has yet to provide financial coverage.

Upon review of the financial assurance documentation, the following violations were found.

OAC 3745-55-43: Failing to provide financial assurance for closure. At this time, please provide financial assurance to meet the closure cost estimate (\$15,390.00) in your Part B application. Any changes in the closure cost estimate and financial assurance will be will be addressed when the Part B Permit is issued.

OAC 3745-55-47(A): Failing to provide third-party liability coverage for sudden accidental occurrences. At this time please submit evidence of coverage for third-party liability coverage for sudden accidental occurrences at your facility.


