

Dear Mr. Dolkowski:

On April 13, 2007, the Division of Hazardous Waste Management (DHWM) received from Environmental Recycling amendments to the 2005 and 2006 Hazardous Waste Annual Reports. The amendments were sent in response to a March 26, 2007, Partial Return to Compliance Letter. An additional GM form was submitted for each year to report the quantity of lamps in storage as of December 31 of the reporting year. The forms have been reviewed and are satisfactory.

In the April 4 cover letter for the amendments, Todd Hendrick stated that a few errors were found in the recalculation of the WR (Waste Receipt) data. On April 16, I sent Todd an e-mail requesting details on the corrections. I received the corrections today. The thermostat receipts were reduced in quantity on seven WR forms.
