Dear Mr. Meyers:

On March 31, 2010, Ohio EPA Division of Hazardous Waste Management (DHWM) conducted a compliance evaluation inspection at the All Ohio Motorsports (Ohio Motorsports) facility located at 23361 Aurora Road in Bedford Hts., Ohio. Ohio Motorsports is a motorcycle dealership, and at the time of this inspection qualified as a Conditionally Exempt Small Quantity Generator (CESQG) of hazardous waste. No hazardous waste streams are currently generated by Ohio Motorsports. Ohio Motorsports generates used oil and spent lead-acid batteries which are shipped off site for recycling

The purpose of this inspection was to determine Ohio Motorsports compliance with Ohio's hazardous waste laws and regulations as found under the Ohio Revised Code and Ohio Administrative Code ("ORC" and "OAC" respectively). Ohio Motorsports was represented by you while Ohio EPA was represented by me. Ohio EPA's inspections included an inspection of the Ohio Motorsports facility and a review of written documentation.

Based upon this inspection Ohio EPA has determined that Ohio Motorsports violated the following state hazardous waste regulation:

1. **OAC Rule 279-22C(1) Used oil requirements for generators:** *Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."*

At the time of this inspection, Ohio EPA observed one fifty-five gallon container of used oil which was not labeled with the words "Used Oil".

Upon observation of this violation, Ohio EPA provided you with Used Oil labels and observed while you labeled the containers. Ohio EPA therefore considers this violation abated and no further action is required.
