Dear Mr. Berkes:

Thank you for accompanying me during Ohio EPA's February 14, 2011, inspection of Artisan Industries' (Artisan) facility in Cleveland, Ohio. I inspected Artisan to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). My inspection included a review of company operations and written documentation. During the inspection, I also helped you identify ways to prevent pollution by reducing waste.

The Artisan Industries Company manufactures metal stampings and parts for various industries. The Grant Avenue facility currently generates one hazardous waste stream, spent mineral spirits (D001), from a parts washer serviced by the Kwik Klean Company. The facility's rate of generation makes Artisan Industries a conditionally exempt small quantity generator of hazardous waste.

The following violation of Ohio's hazardous waste rules was found during this inspection. In order to correct this violation you must do the following and send me the required information ***within 30 days*** of the date of this letter:

- 1. Waste Evaluation, OAC 3745-52-11:** Any person who generates a waste must evaluate the waste to determine if it is a hazardous waste in accordance with the criteria set forth in OAC Chapter 3745-51. Artisan violated this regulation by disposing of waste lamps (e.g. fluorescent, sodium) as solid waste without determining whether or not the waste lamps were a hazardous waste. The waste lamps contain mercury and may contain other hazardous metals. The waste lamps may therefore be a hazardous waste.

As an alternative to determining whether your particular waste lamps are hazardous waste, you may wish to manage them as Universal Waste. In general, this would involve saving the waste lamps in a properly labeled and



closed container (e.g. cardboard box) and having them recycled by a lamp recycler (see enclosure *Universal Waste Rules for Handlers of Lamps*).

To abate this violation, submit documentation of Artisan's evaluation of the waste lamps in compliance with Ohio's hazardous waste regulations. **Alternatively**, if **Artisan chooses to manage the waste lamps as Universal Waste and recycle the lamps through an approved lamp recycler, indicate this in your response letter.**
