Dear Mr. Reddinger:

On April 29, 2010, this writer, representing Ohio EPA's Division of Hazardous Waste Management (DHWM), visited the Buckeye State Welding and Fabricating, Inc. (Buckeye State Welding) facility located at 131 Buckeye Street in Elyria, Ohio to conduct a hazardous waste compliance evaluation inspection (CEI). Buckeye State Welding was represented by you.

The purpose of the inspection was to determine Buckeye State Welding's compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The inspection included a review of the facility's operations and the management of wastes. Buckeye State Welding was inspected for the requirements of a conditionally exempt small quantity generator (CESQG) of hazardous waste and a used oil generator.

On May 10, May 18, May 19, June 4, June 10 and June 22, 2010, Buckeye State Welding submitted information concerning waste evaluation information, waste and used oil shipments and universal waste lamp management.

Based on the inspection, Ohio EPA identified the following violation:

- 1. OAC rule 3745-279-22(C)(1), Used Oil Storage Requirements for Generators:** Used oil generators must store used oil in containers and tanks that are in good condition and not leaking. The containers and aboveground tanks must be labeled with the words "Used Oil."

Buckeye State Welding failed to label seven, 55-gallon drums with the words "Used Oil." During the inspection, the drums were labeled as "Used Oil." Additionally, the used oil was shipped off-site on June 10 and June 17, 2010 to a used oil facility.
This violation has been adequately abated. No further response is necessary.

2. **OAC rule 3745-273-13(D)(1), Universal Waste Management Standards for Small Quantity Handlers:** A small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

Buckeye State Welding failed to accumulate universal waste lamps in closed containers. On May 10, 2010, Buckeye State Welding submitted photographs to demonstrate that the lamps were being accumulated in closed containers. **This violation has been adequately abated. No further response is necessary.**

3. **OAC rule 3745-273-14(E); Labeling/marking Standards for Small Quantity Handlers of Universal Waste:** Universal waste lamps must be labeled/marked with one of the following phrases: "universal waste lamp(s)," or "waste lamp(s)" or "used lamp(s)."

Buckeye State Welding failed to label/mark universal waste lamps with the words required by this rule. On May 10, 2010, Buckeye State Welding submitted photographs to demonstrate that the lamps were appropriately labeled/marked. **This violation has been adequately abated. No further response is necessary.**

4. **OAC Rule 3745-273-15(C), Accumulation Time Limits - Standards For Small Quantity Handlers of Universal Waste:** A small quantity handler of universal waste must be able to demonstrate the length of time that the universal waste has been accumulated.

Buckeye State Welding failed to track the length of time that the universal waste lamps were accumulated. On May 18, 2010, Buckeye State Welding shipped the lamps to a universal waste handling facility. **This violation has been adequately abated. No further response is necessary.**


