On February 9, 2011, the Ohio Environmental Protection Agency (EPA), Division of Hazardous Waste Management (DHWM), conducted a compliance evaluation inspection at Center-Tyler Auto Body & Service, Inc. (Center-Tyler), 8700 Tyler Blvd., Mentor, Ohio. The purpose of the inspection was to determine Center-Tyler's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). Center-Tyler was represented by you and Ron Winland and the Ohio EPA was represented by Kim Gallagher and me.

Center-Tyler is an auto body shop. The hazardous waste stream we identified is a D001 spent solvent generated from cleaning HVLP paint guns. After reviewing hazardous waste manifests, it appears that Center-Tyler generates less than 25 gallons of hazardous waste in a calendar month, making Center-Tyler a conditionally exempt small quantity generator of hazardous waste.

As a conditionally exempt small quantity generator of hazardous waste (CESQG), Center-Tyler is not required to obtain a generator hazardous waste ID number. When you ship hazardous waste off site, instead of putting a generator ID number in box 1 of the Uniform Hazardous Waste Manifest, you can write in the space CESQG.

About two years ago your business moved to your current location at 8700 Tyler Blvd. from 8477 Tyler Blvd. Center-Tyler had been assigned the generator ID number OHD097950935 at the 8477 Tyler Blvd location. You cannot use this number at your new location. Should you ever need a generator ID number for at your new location, you will need to fill out paperwork to have a new generator ID number assigned to 8700 Tyler Blvd. I have sent a memo to the Information Services Unit at the Ohio EPA's Central Office letting them know that the ID number at the former location should be deactivated.

During the inspection I gave you a copy of guidance concerning the management of spent fluorescent lamps. The link to the following document will provide you with additional guidance: Ohio's Universal Waste Rules: Are You Handling Used Lamps Correctly?, 2008

The following violation of the used oil rules was noted:

- 1. Ohio Administrative Code (OAC) 3745-279-22(C)(1); Containers and above ground tanks that are used to store used oil must be labeled with the words, "Used Oil".**


A 250 gallon tank and a small plastic drum used to collect used oil were not labeled "Used Oil" as is required by this rule. This violation was abated at the time of the inspection when you placed stickers labeled "Used Oil" onto the used oil collection tank and drum. No further action is required by you.

Failure to list specific deficiencies and/or violations in this communication does not relieve Center-Tyler from the responsibility of complying with all applicable laws, rules and regulations.
