RE: CHANDLER PRODUCTS, OHD081779449, USED OIL NOTICE OF VIOLATION (NOV)/RETURN TO COMPLIANCE (RTC), CUYAHOGA COUNTY

Dear Mr. Pushpak:

On April 1 and 16, 2010, this writer and Wade Balsler, representing Ohio EPA's Division of Hazardous Waste Management (DHWM), visited Chandler Products (CP) located at 1491 Chardon Rd., Cleveland, Ohio. The purpose of the visit was to determine your status as a hazardous waste generator and provide you with technical assistance information. You and Ron Quinoness represented CP.

The following represents Ohio EPA's findings:

On August 18, 1980, Monogram Chandler Products notified the U. S. EPA of its small quantity generator (SQG) status. This location was assigned an identification number, OHD081779449. This number is used to track the generation and offsite management of hazardous waste. Please note that the OHD identification number remains with the site location address.

Ohio EPA understands that CP is a member of the Elgin Fastener Group which includes other offsite manufactures involved in the manufacturing of bolts, other fasteners and cold formed products used in diesel engines, transmissions, locomotives and other military markets. Precision Screw & Bolt (PSB) is another member of the group which is also located at this site address.

Based upon the information gathered during these visits, it appears that Chandler Products is a Conditionally Exempt Small Quantity Generator (CESQG) of hazardous waste. Chandler Products is a used oil generator. Used oil is stored in tanks and containers onsite. Chandler generates a "grind swag" or "grinder sludge" which is a by-product of CP's grinding process. The sludge or swag is managed in containers onsite as a non-hazardous waste.

Enclosed is the Used Oil Checklist.

Ohio EPA found the following violation:

CP failed to mark containers and tanks storing used oil with the words “Used Oil” as required by the Ohio Administrative Code (OAC) 3745-279-22(C).

On April 30, 2010, Ohio EPA received e-mail photo documentation showing that the used oil tank at the rear of the facility is labeled “Used Oil”. Thus, CP has abated the violation.

Ohio EPA is providing you with the following guidance information which may help you in your daily operations:
