Dear Mr. Meek:

On December 7, 2009, this writer, representing the Ohio Environmental Protection Agency (Ohio EPA), Division of Hazardous Waste Management, conducted a compliance evaluation inspection (CEI) at the City Machine Technologies (CMT) facility located at 773 West Rayen Avenue, Youngstown, Ohio. The facility was inspected to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and the rules promulgated thereunder in Chapter 3745 of the Ohio Administrative Code (OAC).

The inspection included a review of the facility's operations, management of wastes, and records. The facility was inspected for the requirements of a conditionally exempt small quantity generator (CESQG) of hazardous waste.

Ohio EPA identified the following violations of Ohio's hazardous waste laws. In order to correct the violations and concerns listed below, CMT must do the following and send me the requested information **within 30 days** of the date of this letter:

1. Waste Evaluation, OAC rule 3745-52-11:
Any person who generates a waste, as defined in OAC rule 3745-51-02, must determine if that waste is a hazardous waste.

The facility failed to properly evaluate waste paint and paint gun cleaning solvent generated at the paint booth.

During the inspection, you indicated the facility would start collecting the waste paint and solvent in a hazardous waste drum. **In order to abate this violation, please submit a photograph that demonstrates a waste drum is in place to collect the waste.**

2. Waste Evaluation, OAC rule 3745-52-11:
Any person who generates a waste, as defined in OAC rule 3745-51-02, must determine if that waste is a hazardous waste.

The facility failed to evaluate spent fluorescent lamps prior to disposal. However, no lamps were currently accumulating on-site.

Upon generation, you indicated during the inspection that the facility would start managing the lamps as a universal waste. **In order to abate this violation, please submit information that identifies where the lamps will be sent off-site for recycling.**

3. Waste Evaluation, OAC rule 3745-52-11:
Any person who generates a waste, as defined in OAC rule 3745-51-02, must determine if that waste is a hazardous waste.

The facility generates a waste from its sand blasting operations. The spent blast media is currently disposed in the general trash. **Please submit waste evaluation information that verifies the spent blast media is not a hazardous waste, or documentation identifying that it will be sent for scrap metal recycling.**

Comments:

4. Please review, sign and submit the enclosed updated *RCRA Subtitle C Site Identification* form to update the facility's information. Mail the completed form to: Ohio EPA-DHWM, P.O. Box 1049, Columbus, Ohio, 43216-1049.
5. The facility generates a few spent aerosol cans per year. In general, the facility must ensure that each can is empty prior to disposal or scrap metal recycling. Two articles that explain the waste evaluation process for aerosol cans is enclosed.
6. The following technical assistance documents were provided to you during the inspection:
- Universal Waste Rules for Handlers of Lamps, and recycler listing;
 - Identifying Your Hazardous Waste;
 - OCAPP Compliance assistance and pollution prevention brochure.
