Dear Mr. Kysela:

On December 11, 2009, this writer, representing Ohio EPA, Division of Hazardous Waste Management (DHWM), visited the MBI Products Company (MBI) facility located at 801 Bond Street in Elyria, Ohio to conduct a hazardous waste compliance evaluation inspection (CEI). MBI was represented by Ken Visage, Don Clark and you.

The purpose of the inspection was to determine MBI's compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The inspection included a review of the facility's operations and the management of wastes. MBI was inspected for the requirements of a conditionally exempt small quantity generator (CESQG) of hazardous waste.

During the inspection, it was learned that MBI purchased the facility from Ames, Inc. approximately 4.5 years. Ames, Inc. no longer operates at this location.

Based on the inspection, Ohio EPA identified the following violations:

- OAC rule 3745-273-13(D)(1), Universal Waste Management Standards for Small Quantity Handlers:** A small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

MBI failed to accumulate universal waste lamps in containers. On December 14, 2009, MBI submitted photographs to demonstrate that the lamps were being accumulated in a closed container. **This violation has been adequately abated. No further response is necessary.**

- OAC rule 3745-273-14(E); Labeling/marketing Standards for Small Quantity Handlers of Universal Waste:** Universal waste lamps must be labeled/marked with one of the following phrases: "universal waste lamp(s)," or "waste lamp(s)" or "used lamp(s)."

MBI failed to label/mark universal waste lamps with the words required by this rule. On December 14, 2009, MBI submitted photographs to demonstrate that the lamps were labeled/marked. **This violation has been adequately abated. No further response is necessary.**
