Thank you for your response to Ohio EPA's December 10, 2008 Partial Return to Compliance (PRTC) letter. Ohio EPA received the following responses from PPI:

By e-mail dated January 6, 2009 PPI submitted information and documentation, including:

- Updated pages of the facility contingency plan with home addresses and home phone numbers of current emergency coordinators, emergency first line supervisor list and the individual responsibility of the hazardous waste program.

This documentation was followed up with hard copies of said documents on January 7, 2009.

By letter dated January 9, 2009, Ohio EPA received the following documentation:

- Receipts from Federal Express demonstrating that a copy of the facility contingency plan has been sent to the emergency authorities that may be requested to respond in the event of an emergency at the facility.

My review of this documentation reveals that PPI has adequately demonstrated abatement of the following hazardous waste violations cited in Ohio EPA's June 26, 2008 NOV letter and is hereby returned to compliance:

OAC 3745-65-52 (D) Content of contingency plan


