Dear Mr. Philbrick:

On September 15, 2009, this writer, representing the Ohio Environmental Protection Agency (Ohio EPA), Division of Hazardous Waste Management, conducted a compliance evaluation inspection (CEI) at Sandy's Auto Body located at 4304 Youngstown-Poland Road, Youngstown, Ohio. The facility was inspected to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and the rules promulgated thereunder in Chapter 3745 of the Ohio Administrative Code (OAC).

The inspection included a review of the facility's operations, management of wastes, and records. The facility was inspected for the requirements of a conditionally exempt small quantity generator (CESQG) of hazardous waste.

Ohio EPA identified the following violation of Ohio's hazardous waste laws:

1. Waste Evaluation, OAC rule 3745-52-11:
Any person who generates a waste, as defined in OAC rule 3745-51-02, must determine if that waste is a hazardous waste.

The facility failed to evaluate spent fluorescent lamps prior to disposal.

Upon generation, you indicated during the inspection that the facility would start managing the lamps as a universal waste and have them managed by Chemtron Corporation. **Based upon this information, this violation is abated no further response is required.**

2. Please submit an updated *RCRA Subtitle C Site Identification* form, specifically noting the facility the facility is now a CESQG of hazardous waste. This form was provided to you during the inspection.
