Dear Mr. Woodall

Thank you for cooperating with my hazardous waste inspection on July 26, 2011. You and Tony Bologna represented Wildwater Kingdom. My inspection included a review of your operations, your recent manifests/bills of lading, and a walk through of areas at your facility that accumulate spent lamps, batteries and used oil.

You described your operations and confirmed that no hazardous wastes other than universal wastes are currently generated. In May, an accumulation of several years of paint materials was cleaned out of storage and sent to an off-site hazardous waste treatment/recycling facility. One parts washer is in service but records indicate a "continued use" solvent is generated rather than a hazardous waste. Used oil is also generated in the maintenance department and sent off-site for recycling.

The following violations were noted.

1. Waste Battery Labeling – Ohio Administrative Code (OAC) 3745-273-14(A)

Two unlabeled closed buckets of spent batteries were noted in the IT building. As universal wastes, these need to be labeled "universal waste – batteries", "waste batteries", or "used batteries". Please submit a photograph showing that the proper labeling has been added to these buckets if they are still being used or submit documentation confirming that they have been sent off-site for recycling and affirm that this labeling will be used for future accumulations.

Also an outdoor closed yellow plastic container labeled "batteries only" contained an assortment of waste batteries. Your July 27, 2011 e-mail states that this container has been removed from service and all of the batteries that it contained have been placed in proper containers. Please submit a photograph showing that the proper labeling has been added to the new containers if the batteries are still on-site or submit documentation confirming that they have been sent off-site for recycling and affirm that this labeling will be used for future accumulations.

2. **Waste Lamp Containers** – OAC 3745-273-13(D)

A special “light bulb recycling” shed is used to collect waste lamps from all over the park. Some waste lamps were stored loose on shelves, some were loose on the floor, some were in an open plastic garbage can, a few were broken on the floor, and most boxes of waste lamps were open. All waste lamps need to be stored in closed containers that are adequate to prevent breakage.

Via e-mail on July 27, 2011, you stated that the bulbs were being properly boxed and were scheduled to be sent off-site for recycling soon. Please submit documentation (including photographs of the interior of the shed and shipping papers) confirming that all the waste lamps have been sent off-site for recycling. If the waste lamps have not yet been sent off-site, submit photographs of the interior of the shed showing the lamps are being properly managed.

3. **Waste Lamp Labeling** – OAC 3745-273-14(E)

Not all of the waste lamps were in containers that were labeled as required. Containers of waste lamps must be labeled with the words “universal waste – lamps”, or “waste lamps” or “used lamps”. Please submit photographs showing all waste lamps are in closed containers with proper labeling or if lamps have already been recycled, affirm that that will be your practice for future accumulations of waste lamps.

4. **Universal Waste Lamp Accumulation Time** – OAC 3745-15(A) & (B)

Shipping papers indicated universal waste lamps were last sent off-site for recycling on March 3, 2010. In general, these wastes can accumulate for no longer than one year.

Via e-mail on July 27, 2011, you stated that the bulbs were being properly boxed and were scheduled to be sent off-site for recycling soon. Please submit documentation (including photographs of the interior of the shed and shipping papers) confirming that all the waste lamps have been sent off-site for recycling. If the waste lamps have not yet been sent off-site, submit photographs of the interior of the shed showing the lamps are being properly managed and provide the date the lamps will be sent off-site for recycling.

5. **Used Oil Container Label** – OAC 3745-279-22(C)

One drum of used oil in the maintenance building was unlabeled. Containers of used oil are required to be labeled with the words “used oil”. Your July 27, 2011 e-mail states that the used oil in this drum was transferred into the outdoor used oil tank on the hill, which is properly labeled. Further you affirmed that future accumulations of used oil in the Maintenance shop will have the proper label. You have adequately addressed this violation at this time.

Please address all of the above violations immediately and submit the requested documentation within 30 days of the date of this letter.
