Dear Mr. Voldrich:

Thank you for your September 21, 2008 response to Ohio EPA's September 5, 2008 Notice of Violation (NOV) letter. You submitted documentation and information including:

- One photograph demonstrating that containers of universal waste are being kept closed and appropriately labeled as Universal Waste.
- One photograph demonstrating containers of universal waste are dated with an accumulation start date in order to track how long the lamps have been on site.
- One photograph demonstrating that lamps are being packed carefully with their waffle packing.
- A copy the Suburban Collision's universal waste lamp management protocol.

My review of this documentation reveals that Suburban Collision has adequately demonstrated abatement of the following hazardous waste violations cited in Ohio EPA's September 5, 2008 NOV letter and is hereby returned to compliance:

OAC 3745-273-13(D)(1) Universal waste lamp management

OAC 3745-273-14(E) Labeling/marketing of universal waste

OAC 3745-273-15(C) Accumulation time limits for universal waste

OAC 3745-273-16 Employee Training for Small Quantity handlers of universal waste


