Dear Mr. Wasko:

On September 2, 2011, Ed D'Amato and I of the Ohio EPA Division of Materials and Waste Management, conducted a hazardous waste complaint investigation at Wasko's Marathon Service, located at 8177 Brecksville Rd, Brecksville, Ohio. The purpose of our visit was to investigate a complaint received by Ohio EPA alleging that the facility paints cars without air filtration, dumps anti-freeze down the drain, puts scrap tires into the garbage/dumpster, and that off-site management of used oil is questionable. You represented the facility during the inspection.

Wasko's Marathon Service is a gasoline station and auto repair shop. During our walk through of the auto repair shop we did not find any violations of the hazardous waste rules. You were able to provide us records showing that the used oil and anti-freeze are being properly managed. We didn't see any equipment or paint that would suggest that cars are being painted on-site. You showed us the contract for the removal of the used oil underground storage and stated that occasionally tires will be put in the dumpsters after hours by unknown people. The complaint could not be substantiated.

I have enclosed copies of the inspection checklists used for this investigation. The following violation of the used oil rules was noted:

1. **Ohio Administrative Code (OAC) 3745-279-22(C)(1); Containers and above ground tanks that are used to store used oil must be labeled with the words, "Used Oil".**

The 55-gallon drum of used oil was properly labeled but the drip pans used to collect oil being drained from oil filters were not labeled as is required by this rule. The drip pans were labeled with the "Used Oil" by placing labels on them. No further action is required regarding this violation.


