Dear Mr. Mirante:

On November 3, 2010, I conducted an inspection of the City of Youngstown Waste Water Treatment Plant located at 725 Poland Avenue, Youngstown, Ohio, for compliance with Ohio's hazardous waste and used oil laws and regulations. On November 12, 2010, I sent you a Notice of Violation (NOV) letter as follow-up to the inspection. A copy of that letter is attached for your reference.

My NOV letter of November 12, 2010 requested that you respond to Violation Numbers 1 and 3 by sending the requested information to this office within 30 days. Subsequent to my NOV letter of November 12, 2010, I spoke to Denise Seman of your staff on December 28, 2010 and sent her a fax of the NOV letter of November 12, 2010.

I subsequently received your letter dated January 7, 2011 which stated that work was in progress to address Violation Numbers 1 and 3. Subsequent to receipt of this letter, I sent you several emails and left several messages with your office, all requesting a response which documented that all the work necessary to respond to Violation Numbers 1 and 3 had been completed. I also spoke to you on May 16, 2011 and reiterated the same message.

However, I have not yet received your response documenting that the work necessary to complete the response to Violation Numbers 1 and 3 has been completed. That response is now significantly past due.
