Dear Mr. Hassmann:

Thank you and Michael Clement, Lab Manager, for accompanying me during the Ohio Environmental Protection Agency's (Ohio EPA) July 21 and August 3, 2011, compliance evaluation inspection of your facility. I inspected Ashland University's maintenance shop and chemistry laboratories to determine the facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This inspection consisted of a walkthrough of the facility and paperwork review. Pollution prevention options were also discussed during this inspection. This letter will explain the violations I found.

Ashland University (AU) operates a service shop to conduct maintenance of university facilities and on university vehicle fleet and several chemistry labs located in the Kettering Science Building. AU generates spent solvent/paint waste (<5 gallons per month, D001), and used oil (5-10 gallons/month). Used oil is being given to another business (Aber Garage) to be burn for energy recovery. During the inspection I stated that you should stop this practice immediately unless you want to become a used oil marketer. You mentioned that AU will be looking for a company to send the used oil for recycling. From its lab research activities, AU generates: High Performance Liquid Chromatography waste (<1 gallon per month, D001), halogenated liquid waste (<2 gallons per month, D001, F001, F002), and heavy metals liquid waste (2 gallons per month, D006, D008). In addition, AU manages spent lamps, batteries, and ballasts as universal wastes which are all currently being recycled off-site. At the time of this inspection, AU was a conditionally exempt small quantity generator of hazardous waste.

I found the following violation of Ohio's hazardous waste laws. This violation must be abated within 30 days of receipt of this letter.

**1. OAC 3745-279-24 Used Oil Shipments.**

Used oil generators must ensure that their used oil is transported only by transporters who have obtained U.S. EPA identification numbers. If the used oil is self-transported, the generator must ensure that the collection center is registered with Ohio EPA to manage used oil.

AU failed to transport the used oil by a transporter that has obtained a U.S. EPA identification number. In addition, the used oil collection entity was not registered with Ohio EPA to manage used oil.

To abate this violation AU must respond in writing future plans on how to properly manage used oil. Keep in mind that a generator of used oil may self-transport up to a 55-gallon drum of used oil utilizing a company vehicle to a registered facility.

The Division of Materials and Waste Management has created an electronic news service to provide you with quick and timely updates on events and news related to hazardous waste activities in Ohio. As we discussed during the inspection, if you find ways to recycle reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs. 
