Dear Mr. Huff:

On January 13, 2010, Ohio EPA conducted a complaint investigation and a compliance evaluation inspection of Packaging Corporation of America (PCA) located in Ashland, Ohio. The purpose of this visit was to determine PCA's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC) and to determine the validity of the complaint. The complaint alleged that oil and antifreeze were being dumped outside by the dumpsters. The inspection included a tour of the facility and a review of your paper work and disposal practices.

PCA manufactures corrugated cardboard which is made into packaging products (i.e., boxes). Water-based ink is used on the boxes. Any excess ink goes to their onsite WWTP and goes through a filter press. The filter cake (non-hazardous) is then sent to Milliron for recycling. PCA's used oil and universal waste (batteries and fluorescent bulbs) are picked up by Safety Kleen. Safety Kleen also services their parts washers which are part of the continued use program. At the time of inspection, Ohio EPA considered PCA a non-generator of hazardous waste.

During Ohio EPA's complaint investigation, no evidence was found proving that antifreeze or oil was being dumped by the dumpster at the rear of the property. Therefore, the complaint is considered closed.

I found the following violations of Ohio's hazardous waste laws. PCA has since abated all of the violations; therefore, no response to this letter is necessary.

1. Used Oil Storage Requirements – OAC Rule 3745-279-22(C)(1)

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil".

PCA failed to mark their 55-gallon drums with the words "Used Oil".

On January 13, 2010, PCA submitted photo documentation showing that the used oil drums were labeled with the words "Used Oil." **Therefore, this violation has been abated.**

2. **Universal Waste Storage – OAC Rule 3745-273-14(A)**

Universal waste containers used to store batteries must be labeled with the words "Universal Waste Batteries" or "Waste Batteries" or "Used Batteries".

PCA failed to have their universal waste battery container labeled.

On January 13, 2010, PCA submitted photo documentation showing that the universal waste battery storage drum was labeled properly. **Therefore, this violation has been abated.**

If you find ways to recycle, reduce or altogether eliminate the amount of waste your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements.


