Dear Mr. Camden:

Thank you for accompanying Melissa Boyers and me during the Ohio Environmental Protection Agency's (Ohio EPA's) March 24, 2010, hazardous waste compliance evaluation inspection of The Courier located at 701 West Sandusky Street in Findlay, Ohio. We inspected The Courier to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and Chapter 3745 of the Ohio Administrative Code. Pollution prevention options were also discussed during this inspection. This letter will explain the violations found and what you need to do to correct the remaining violations.

The Courier is a newspaper printer. The Courier generates fluorescent bulbs which are currently disposed of as solid waste. There were no bulbs in storage at the time of our inspection. You also generate press wash which is hazardous waste and is disposed of by Safety Kleen. You also have a parts washer which uses the same press wash material. The parts washer is disposed with the press wash material. The Courier also generates a small amount of used oil (less than 1 gallon a month) which is being collected and taken home by an employee. The Courier recycles paper and cardboard. You also have shop rags which are laundered. The Courier is currently operating as a conditionally exempt generator of hazardous waste. This means you generate less than 20-25 gallons of hazardous waste a month.

The following violations of Ohio's hazardous waste rules were observed and noted during the inspection. In order to correct these violations you must do the following and send me the required information within 30 days of your receipt of this letter:

1. OAC Rule 3745-52-11, Waste Evaluation:

Any person who generates a waste must determine if that waste is a hazardous waste by using generator knowledge or by testing the waste.

The Courier failed to have waste evaluation documentation or an established recycling plan in place for the fluorescent bulbs generated at the facility.

The Courier must immediately cease disposing of the fluorescent bulbs as non-hazardous waste until a proper waste evaluation has been completed. Fluorescent bulbs typically contain mercury, lead or cadmium.

During our inspection, I provided you with a fact sheet regarding fluorescent lamps and a list of fluorescent lamp and ballast recyclers. Please review this information and contact me if you have any questions.

Basically, you could run analytical to determine if the bulbs contain mercury, lead, or cadmium (if you would like to continue to dispose of them) OR you can choose to handle them through the **universal waste rules by recycling**. When the bulbs are recycled as a universal waste, they are not considered a hazardous waste. You must ensure that they are recycled within one year of being generated and that you keep documentation showing this. Also, you must label the box containing the burned out bulbs (prior to recycling) with the words "universal waste lamps".

At the time of our inspection, you indicated that you plan to use Environmental Recycling to recycle your bulbs in the future. To abate this violation, please confirm how you plan to manage the bulbs.

2. OAC Rule 3745-279-24, Used Oil - Off-Site Shipment:

Generators shall ensure that their used oil is transported only by transporters who have obtained an EPA identification number.

The Courier has been giving the used oil they generated to an employee.

The Courier must immediately cease giving used oil to any person or transporter who does not have an EPA identification number. To abate this violation, The Courier must notify Ohio EPA with how you plan to manage you used oil in the future and provide the applicable documentation for review.

3. OAC Rule 3745-279-22(C)(1), Used Oil Labeling:

Containers, aboveground tanks, and fill pipes used for underground storage tanks shall be labeled or marked clearly with the words "used oil".

There were several containers located next to the press that were not properly labeled.

To abate this violation, The Courier must properly label the containers with the words "used oil" and submit a photographic documentation to me.
