Dear Mr. Runion:

Thank you for accompanying me during the Ohio Environmental Protection Agency's (Ohio EPA's) March 10 and 16, 2009, hazardous waste compliance evaluation inspection of Rick Runion's Used Car Center (RRUCC) located at the address stated above. I inspected RRUCC to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection. This letter will list observations I made during the inspection, and the violation found.

RRUCC is a small used car sale lot. RRUCC operates an automotive service garage, generates used oil and used antifreeze. In addition, spent lamps are currently being disposed as a solid waste. Prior to conducting this inspection a routine review of the U.S. EPA data base revealed that this U.S. EPA id number makes reference to AAMCO Transmission. You stated that AAMCO has not operated at the facility for many years and that you moved in and started operation in 1998.

I found the following violations of Ohio's hazardous waste laws. You must provide me the requested information within 30 days of receipt of this letter.

**1. OAC Rule 3745-52-11: Waste Evaluation**

Any person, who generates a waste, as defined in Rule 3745-51-02 of the administrative code, must determine if that waste is a hazardous waste.

- a) RRUCC has failed to properly evaluate the spent fluorescent bulbs generated at the facility.

During the inspection, you stated that in the past RRUC has disposed of the spent fluorescent light bulbs in the trash. RRUC must not dispose of any spent light bulbs as non-hazardous waste in the local landfill until a proper waste evaluation has been completed. The waste evaluation must be conducted through one of **three options: 1)** RRUC may apply generator knowledge of the hazardous characteristic(s) of the waste in light of the materials or the processes used through adequate documentation [manufacturer analytical information – Toxicity Characteristic Leaching Procedure (TCLP) test results], or **2)** RRUC may take a representative sample of this waste to properly evaluate this waste stream through a laboratory analysis which lists constituents present and at what concentration. RRUC must ensure that the laboratory chosen to perform this sampling utilizes the proper method(s) to evaluate these bulbs.

RRUC must sample the fluorescent bulbs to determine the concentration of mercury (D009), cadmium (D006) and lead (D008) as listed in the OAC Rule 3745-51-24 following the method as outlined in U.S. EPA's SW-846. KCDC may run a total concentration for these constituents as a screening tool. If the concentration is detected for mercury, lead or cadmium at or above the regulatory limit, a TCLP may be required to ensure this constituent is not present above the Ohio EPA regulatory level; or **3)** a combination of options 1 and 2.

If the bulbs are determined to be hazardous through a proper waste evaluation, RRUC will have to manage their bulbs either as 1) a universal waste (OAC Chapter 3745-273) or 2) as a hazardous waste under Ohio's generator standards (OAC Chapter 3745-52). ***Instead of taking samples for analysis as described above, RRUC may recycle their bulbs if they are hazardous or non-hazardous by managing them as universal waste. Ohio EPA would encourage this option as a pollution prevention alternative. Please refer to the information I gave you on how to manage light bulbs as universal waste.***

***To abate this violation,*** RRUC must inform me in writing as to how the facility plans to manage the spent fluorescent light bulbs and other spent light bulbs.

2. **OAC Rule 3745-279-22(C)(1): Labeling**

Containers, aboveground tanks and fill pipes used for underground storage tanks shall be labeled or marked clearly with the words "Used Oil."

The two 55-gallon drum storing used oil were not properly labeled with the words "used oil".

***This violation was abated during the inspection.***

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs. Thus, you may possibly reduce your regulatory requirements. BI is currently recycling scrap, paper and plastic.
