Dear Mr. Whitaker:

Thank Courtney Whitaker for accompanying me during the Ohio Environmental Protection Agency's (Ohio EPA) October 6, 2010, compliance evaluation inspection of your business. I inspected your facility to determine the facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This inspection consisted of a walkthrough of the facility and paperwork review. Pollution prevention options were also discussed during this inspection. This letter will explain the violations I found.

Rick's Auto Sales (RAS) formerly Flagship Auto Body is a previously owned automobile dealership. RAS does not operate an auto-body shop. RAS performs routine mechanical maintenance on automobiles it sells and for individual clients. During the maintenance activities, RAS generates used oil which is mixed with small amount of spent mineral spirits generated from a parts washer. The used oil is then burned for energy recovery on-site. Spent anti-freeze is mostly re-used although a small portion of it is sent-off for recycling. During a phone conversation, you stated that your electrical contractor handles your spent fluorescent light bulbs. Spent light bulbs are recycled. At the time of this inspection, RAS was a conditionally exempt small quantity generator of hazardous waste.

I found the following violation of Ohio's hazardous waste laws. The violation was subsequently abated in an email you sent me on October 19, 2010.

**1. OAC 3745-279-22 (C)(1) Used oil storage container labeling.**

Containers and above ground tanks used to store used oil at generator facilities shall be labeled or marked clearly with the words "Used Oil."

RAS did not label several containers of used and a used oil tanks located outdoors.

On <sup>October</sup> ~~August 19~~, 2010, RAS submitted several photographs via email, showing the proper labeling of used oil containers. **This violation has been abated.**

**General Comment:**

During my inspection, you stated that you are currently having your spent fluorescent light bulbs recycled by your electrical contractor. As the generator, it is in your best interest to ascertain that the spent bulbs are being managed properly by either being properly disposed of or, our preferred method, being recycled. You must keep in mind that if you start accumulating your spent bulbs at your shop, they must be properly stored in closed containers and properly labeled. In addition, you must not accumulate your spent light bulbs longer than 12 months. For your information, I am enclosing documentation regarding the proper management of spent light bulbs.

The Division of Hazardous Waste Management has created an electronic news service to provide you with quick and timely updates on events and news related to hazardous waste activities in Ohio. If you haven't already, we encourage you to sign up for this free service. Please feel free to share this information with your colleagues.

As we discussed during the inspection, if you find ways to recycle reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs. 
