Dear Ms. Meade:

On July 26, 2007, Ed Pulido, MaryAnn Miller and I investigated a complaint at Basil Auto Wrecking, Inc. (Basil) located at 938 St. Rt. 18, Bellevue, Ohio. The complaint was received by the Division of Hazardous Waste Management on December 6, 2006. The complainant alleged the following: that Basil does not properly collect fluids from auto dismantling; it is standard practice for Basil to allow auto fluids to drain onto the ground; and air conditioning lines are cut and Freon is released into the air. This letter will explain the validity of the complaint, the violations we found as a result of our investigation, what you need to do to correct the one outstanding violation, and one general comment.

Basil is a motor vehicle salvage yard. Basil provides vehicle towing services as well as sells new and used auto parts.

Upon arriving at Basil, we spoke with you about the above allegations. You stated the following: you do not drain fluids from automobiles onto the ground; all fluids are collected in 55-gallon drums; you collect and re-use all of your antifreeze on-site; your used oil is picked up by a guy to burn in his used oil furnace; you recycle your batteries with Crown batteries in Fremont; and a certified Freon technician collects and recharges the Freon from your cars.

We walked around your property. We observed where you are storing your used oil and antifreeze. I observed the log from the collecting of Freon from your vehicles. In addition, I observed the bucket where you are collecting your mercury switches from your vehicles and the letter from our Office of Compliance Assistance & Pollution Prevention pertaining to the Ohio Voluntary Mercury Switch Removal Program. You stated that you are participating in this program.

During the investigation, I provided you with the following materials: the Ohio EPA Fact Sheet: The Regulation of Used Oil: An Overview for Ohio Businesses, Used Oil Generators, a list of Used Oil Recyclers, and the publication Environmental Compliance Guide for Motor Vehicle Salvage Yards.

As a result of my investigation, I found the following violations of Ohio's used oil regulations. In order to correct the one outstanding violation you must do the following and send me the required information **within 30 days** of your receipt of this letter:

1. **Used oil storage requirements - proper labels.**  
**OAC 3745-279-22 (C) (1)**

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil."

Basil failed to mark one 55-gallon drum storing used oil with the words "Used Oil".

"Used Oil" was written on the one 55-gallon drum during the investigation. ***Thus, this violation was abated.***

**2. Off-site shipments of used oil by generators.  
OAC Rule 3745-279-24**

Generators shall ensure that their used oil is transported only by transporters who have obtained U.S. EPA identification numbers.

Basil stated that their used oil is not being picked up by a transporter with a U.S. EPA identification number. Currently, a man is picking up Basil's used oil and burns it in his furnace. Basil may be considered a used oil marketer (see general comment number 1 below). Used oil generators have three options for handling their used oil: 1) Generators must have their used oil transported by an entity that has a U.S. EPA identification number and ensure their used oil is recycled; 2) Generators may transport less than 55-gallons of their own used oil to a registered used oil collection center. I have enclosed a copy of registered used oil collection centers in the state; or 3) Basil may burn its own used oil in an on-site space heater as long as all applicable requirements are met. I have enclosed a fact sheet entitled The Regulation of Used Oil: Used Oil Burners. Please consult this and the Used Oil fact sheet given to you during the complaint investigation for more information.

In order to abate this violation, Basil must either 1) submit a copy to me of a contract or some type of documentation indicating a transporter with a U.S. EPA identification number will be picking up Basil's used oil and appropriately recycling it or 2) a disposal receipt from the off-site shipment of their used oil (if the facility is due for a pick-up) indicating that a transporter with a U.S. EPA identification number is now transporting their used oil and that the used oil is taken to an appropriate recycling facility or 3) Basil must submit a copy of a receipt from the drop-off of their used oil at a registered used oil collection center or 4) a summary outlining how they plan to manage their used oil if you decide to purchase a used oil furnace.

**General Comment:**

**1. Shipping used oil off-site to burn.**

Basil shall note that they may be considered a used oil marketer if they continue to allow their used oil to be burned off-site. As a used oil marketer, Basil would be required to determine if their used oil was on or off specification, notify Ohio EPA of their marketing activities, and retain records of the analysis of the used oil. Based on whether the used oil was determined to be on or off specification, other requirements such as ensuring the used oil burner has a U.S. EPA identification number and ensuring delivery of the used oil to the burner may apply. I have enclosed the fact sheet Universal Waste Rules for Handlers of Lamps. Please refer to this for the proper management of fluorescent light bulbs and other lamps that may be generated at Basil.


We did not observe any evidence that Basil was not properly collecting their auto fluids, however as a result of our investigation we did observe the violations as listed above. Please be advised that a full compliance evaluation inspection was not conducted. Ohio EPA's failure to list specific deficiencies or violations in this letter does not relieve you from having to comply with all applicable regulations.
