Dear Mr. Edwards:

Thank you for accompanying me during the October 16, 2009, hazardous waste compliance evaluation inspection (CEI) of Monroeville Industrial Moldings (MIM) located at 75 Ontario Street, Norwalk, Ohio. This inspection was conducted to determine MIM's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). The inspection included a tour of facility operations and a review of facility paperwork.

MIM manufactures highway offset blocks for guard rails using recycled plastics. At the time of inspection, MIM was not a generator of hazardous waste. MIM's used oil and fluorescent bulbs are sent to PSC for recycling.

I found the following violations of Ohio's hazardous waste laws.

1. Universal Waste Storage, OAC 3745-273-13(D)(1)

A small quantity handler of universal waste must manage lamps in a way that prevents releases of any universal waste or component of a universal waste to the environment.

Therefore, a small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

MIM's universal waste storage area for lamps contained multiple lamps which were not stored in closed packages.

On October 19, 2009, MIM submitted a photograph documenting that all lamps were placed in closed packages. **Therefore, this violation is abated.**

2. Universal Waste Storage, OAC 3745-273-14(E)

A small quantity handler of universal waste must label or mark the packages of lamps with the words "Universal Waste - Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)".

MIM failed to have the boxes of used fluorescent bulbs labeled.

On October 19, 2009, MIM submitted a photograph documenting that all packages of lamps were labeled correctly. **Therefore, this violation is abated.**

3. Used Oil Storage Requirements, OAC Rule 3745-279-22 (C) (1)

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil".

MIM failed to mark their used oil totes with the words "Used Oil".

On October 19, 2009, MIM submitted a photograph documenting that all used oil totes were marked with the words "Used Oil". **Therefore, this violation is abated.**

If you find ways to recycle, reduce, or altogether eliminate the amount of waste your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements.
