Dear Mr. Slocum:

On October 30, 2009, Ohio EPA conducted a complaint investigation and a compliance evaluation inspection of Wilbert Plastic Services (Wilbert) located in Bellevue, Ohio. The purpose of this visit was to determine Wilbert's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The inspection included a tour of the facility and a review of your paper work and disposal practices.

Wilbert manufactures plastic auger agitators (and other plastic parts) for appliances. At the time of inspection, Ohio EPA considered Wilbert a non-generator of hazardous waste. Wilbert's parts washer solvent is part of the continued use program through Environmental Specialists. Environmental Specialists also picks up the oily dirt that cannot be recycled, oily rags, and universal waste. CO2 Pure Tech recycles Wilbert's used oil onsite.

During Ohio EPA's complaint investigation, no evidence was found proving oily mop water was being dumped outside the back doors. Therefore, this complaint is considered closed.

I found the following violations of Ohio's hazardous waste laws. Wilbert has since abated all of these violations, therefore, no response to this letter is necessary.

**1. Universal Waste Storage, OAC 3745-273-13(D)(1)**

A small quantity handler of universal waste must manage lamps in a way that prevents releases of any universal waste or component of a universal waste to the environment.

Therefore, a small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

Wilbert's universal waste storage area for lamps contained multiple lamps which were not stored in closed packages.

On November 13, 2009, Wilbert submitted photo documentation showing that the universal waste lamps were now being stored in closed boxes. **Therefore, this violation has been abated.**

**2. Universal Waste Storage, OAC 3745-273-14(E)**

A small quantity handler of universal waste must label or mark the packages of lamps with the words "Universal Waste - Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)".

Wilbert failed to have the boxes of used fluorescent bulbs labeled.

On November 13, 2009, Wilbert submitted photo documentation showing that the universal waste containers were now labeled correctly. **Therefore, this violation has been abated.**

**3. Used Oil Storage Requirements, OAC Rule 3745-279-22 (C) (1)**

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil".

Wilbert failed to mark their 55 gallon drums with the words "Used Oil".

On November 13, 2009, Wilbert submitted photo documentation showing that the used oil drums were labeled with the words "Used Oil". **Therefore, this violation has been abated.**

Ohio EPA will issue an EPA ID number to track our inspection activity at Wilbert's. Wilbert can not use this number for manifesting hazardous waste shipments.

If Wilbert wants to use an EPA ID number for manifesting and other hazardous waste, used oil or universal waste activities, Wilbert must complete and submit a Notification of Regulated Waste Activity form (EPA Form 9029 (Rev. 11/2002)) to Ohio EPA.

If you find ways to recycle, reduce, or altogether eliminate the amount of waste your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements.
