Dear Mr. McGilvery:

Thank you for accompanying me and Rick Hassinger during Ohio EPA's March 4, 2010, complaint investigation (CI) and compliance evaluation inspection (CEI) of Cauffiel Machinery Corp. (CMC) located at 1303 Campbell Street in Toledo, Ohio. We were also accompanied by Mr. Dave Brier, CMC Plant Manager. We inspected CMC to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). Our inspection included observations of facility operations and a review of written documentation. According to the complaint received by Ohio EPA on February 22, 2010, OSHA received allegations that CMC was disposing of hazardous waste in a drain.

CMC manufactures metal processing equipment, such as slitter lines, cut to length lines and rolling mills. CMC designs, fabricates, assembles and tests the equipment it manufactures to customer specifications. CMC performs some limited metal machining. At the time of our inspection, CMC was not generating hazardous waste. CMC generates the following waste:

1. Used Oil: Used oil can come from draining an old gear box or hydraulic line. In the metal machining steps only very small amounts of coolant are applied to the tool with a spray bottle and are used up. Used oil is accumulated in black, steel, 55-gallon drums. Cousins Waste Control Corp. is used to recycle the used oil.

As a result of our complaint investigation we found that there was no evidence that hazardous waste had been disposed down any drain in the facility. We observed a drain in a closet in the men's room as well as a sink and all the toilet facilities. **Therefore, the complaint is not valid and is closed.**

However, as a result of our inspection, we found the following violation of Ohio's hazardous waste laws. In order to correct this violation, you must do the following and send me the required information, **within 30 days** of your receipt of this letter:

**1. Used Oil Container Labeling  
OAC Rule 3745-279-22(C)(1)**

Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil." During the inspection we found two 55-gallon drums and approximately six pails of used oil that had not been labeled with the words "Used Oil".

In order to correct this violation, CMC must immediately mark or label the drums containing used oil with the words "Used Oil", pour the contents of the pails of used oil into a properly labeled used oil drum and provide me with photographic documentation that this has been done.

As a used oil generator you are required to store used oil in containers or aboveground tanks that are in good condition (no severe rusting, apparent structural defects or deterioration) and not leaking. Containers, aboveground tanks and fill pipes for underground tanks must be labeled with the words "Used Oil." If leaks are detected, the generator must stop the release; contain the release; clean up and manage properly the released used oil and other materials related to the release; and, if necessary, repair or replace any leaking containers or tanks prior to returning them to service. I have enclosed copies of the following used oil fact sheets: The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, and Used Oil Recyclers. Please review these carefully and contact me immediately if you have any questions.

Please be aware that incandescent, fluorescent, metal halide, neon, high-intensity discharge, high-pressure sodium and mercury-vapor lamps could be hazardous waste when discarded. Fluorescent lamps may contain up to 40 milligrams (mg) of mercury, depending on the brand and manufacturer. Lamps may also contain lead and cadmium. Many lamps exhibit a characteristic of toxicity for heavy metals when disposed. I have enclosed copies of the following documents, to assist you in properly managing your spent lamps: Fluorescent Lamps: What You Should Know and Computer, Fluorescent Lamp and Ballast Recyclers. I recommend that you review these documents carefully and contact me if you have any questions. The first document describes the rules you must follow in order to manage lamps as a universal waste.

You may be able to further reduce the waste your company generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs and you may possibly reduce your regulatory requirements. I have enclosed copies of Pollution Prevention Opportunities, a worksheet that can help you recognize opportunities for reducing waste and conserving energy at your business, and the fact sheet Management of Electronic Waste from Businesses. Please review this information and contact me if you have any questions.


