Dear Mr. Fauver:

On August 21, 2009, Wendy Miller and I inspected the Charlie's Dodge facility located at 725 Illinois Avenue in Maumee, Ohio. We inspected Charlie's Dodge to determine the facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). Our inspection included a tour of the facility service department and body shop as well as a review of facility records. We also helped Charlie's Dodge identify ways to prevent pollution by reducing the waste the facility generates.

Charlie's Dodge is a full-service automotive dealership which operates a service shop and auto body repair facility at the 725 Illinois Avenue location. Company records reviewed during this inspection indicate that Charlie's Dodge generates approximately 50 gallons per month of (D001 ignitable/D008 lead/D039 tetrachloroethylene) spent parts washer solvent in the service department, approximately 2 gallons per month of (D001 ignitable/F003 spent non-halogenated solvent/F005 spent non-halogenated solvent) spent paint gun cleaning solvent in the body shop and approximately 50 gallons per month of (D001 ignitable/D008 lead/D018 Benzene) waste gasoline.

Charlie's Dodge also generates spent lead acid automotive batteries that are exchanged with new batteries by a battery wholesaler, used oil which is shipped off-site for recycling, used oil filters which are sent off-site for disposal, used anti-freeze/coolant which is sent off-site for recycling, used automotive tires which are sent off-site for shredding, used paint filters which are sent off-site for disposal and spent fluorescent light bulbs which are sent off-site for recycling.

We found the following violations of Ohio's hazardous waste laws during the inspection. In order to correct these violations you must do the following and send me the required information **within 30 days** of your receipt of this letter:

1. **OAC Rule 3745-52-34(D)(5)(a); Emergency Coordinator:** A generator must designate at least one employee who is either on the premises or on call (i.e., available to respond to an emergency by reaching the facility within a short period of time) with the responsibility for coordinating all emergency response measures in the event of a fire, explosion, or other release of hazardous waste which could threaten human health or the environment.

Charlie's Dodge failed to designate at least one emergency coordinator for the facility.

To abate this violation, Charlie's Dodge must designate at least one emergency coordinator for the facility who has the responsibility for coordinating all emergency response measures in the event of a fire, explosion, or other release of hazardous waste. Charlie's Dodge should submit the name of the emergency coordinator(s) to me along with their position description(s).

2. **OAC Rule 3745-52-34(D)(5)(b); Emergency Information Posting:** A generator must post the name and telephone number of the facility emergency coordinator, the location of fire and spill control equipment and the telephone number of the fire department by a telephone located near the hazardous waste storage area.

Charlie's Dodge failed to have emergency information posted near any telephone at the facility.

To abate this violation, Charlie's Dodge must post the name and telephone number of the facility emergency coordinator, the location of fire and spill control equipment and the telephone number of the fire department by a telephone located near the hazardous waste storage areas. Charlie's Dodge has two hazardous waste storage areas. One is located in the body shop and the other is located behind the service department. Ohio EPA recommends that this information be posted in the office located in the body shop and the office located in the service department. Charlie's Dodge should submit to me a photograph of the posted information. The photograph should clearly show the information on the posting and the location of the posting.

3. **OAC Rule 3745-66-74; Hazardous Waste Storage Area Inspections:** A generator must inspect areas where hazardous waste is stored. These inspections must be conducted at least once per week. In addition, these inspections must be recorded in a log or summary.

Charlie's Dodge failed to inspect the hazardous waste storage area in the body shop. In addition, Charlie's Dodge failed to inspect the hazardous waste storage area located behind the service area.

To abate this violation, Charlie's Dodge must inspect the hazardous waste storage area in the body shop and behind the service area on a weekly basis. These inspections must be recorded in a log or summary. Charlie's Dodge should send me a copy of the inspection log or summary which demonstrates that Charlie's Dodge has started inspecting these storage areas.

4. **OAC Rule 3745-273-14(E); Labeling of Universal Waste Lamp Containers:** A small quantity handler of universal waste lamps must store used lamps in a closed container that is marked or labeled with the wording "Universal Waste Lamp(s)", "Waste Lamp(s)", or "Used Lamp(s)". The small quantity handler must also track the accumulation of the spent lamps to ensure spent lamps are not stored for greater than 365 days. This can be accomplished with recycling receipts or by marking the container with the accumulation start date (the day the first lamp is placed in the container).

Charlie's Dodge failed to store universal waste lamps in containers marked or labeled with the wording "Universal Waste Lamp(s)", "Waste Lamp(s)", or "Used Lamp(s)". At the time of the inspection, Charlie's Dodge was storing universal waste lamps in containers marked "Used Bulbs". Labels marked "Universal Waste Lamps" were applied to the containers during the inspection.

This violation is abated and requires no further action.

In addition to the above violations, Ohio EPA has the following concern:

1. Charlie's Dodge began accumulating spent fluorescent lamps in containers for recycling a few months prior to this inspection. At the time of the inspection, you indicated that your facility has not yet determined where to ship the spent lamps for recycling. We provided you with a list of fluorescent lamp recycling facilities known to the Ohio EPA. In your response to the above violations, Charlie's Dodge should also indicate who the facility has contacted to dispose of the spent universal waste fluorescent lamps.

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce or eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs as well as regulatory requirements. If you can find a way to reduce your hazardous waste generation to less than 25 gallons per month you will reduce your regulatory requirements to those of a conditionally exempt small quantity generator. During the inspection we observed the following potential pollution prevention (P2) opportunities associated with your operations:

1. Facility records reviewed during the inspection indicate that Charlie's Dodge currently sends approximately 50 gallons of hazardous waste spent parts cleaning solvent off site each calendar month. Ohio EPA suggests that Charlie's Dodge pursue several pollution prevention opportunities to reduce the amount of hazardous waste parts cleaning solvent that your facility generates. These opportunities include: reducing the amount of parts washers you use at the facility; evaluating the need to replace your solvent on a monthly basis; substituting a non-hazardous high flashpoint solvent, aqueous solvent or microbial solvent for the current solvent used; and entering into a continued use program for your spent parts washing solvent.
2. Facility records reviewed during the inspection indicate that Charlie's Dodge currently sends approximately 50 gallons of contaminated gasoline off site each month as hazardous waste. Fuels that become unintentionally contaminated during storage are commercial chemical products (CCPs) because the fuels have not been used. In addition, CCPs that are normally fuels that are burned for energy recovery are not wastes and, therefore, are not hazardous wastes.

The generator and subsequent handlers of the contaminated gasoline that will be burned for energy recovery are not required to manage it as a hazardous waste. However, any wastes that result from processing the contaminated fuel must be evaluated to determine if they are hazardous wastes. If the wastes are hazardous they must be managed in accordance with all applicable hazardous waste rules. Ohio EPA recommends that Charlie's Dodge evaluate your contaminated gasoline to determine if it meets the above criteria to be managed as a CCP.

3. Facility records reviewed during the inspection indicate that Charlie's Dodge currently sends approximately 900 gallons of used oil off site each month for recycling. Charlie's Dodge may want to consider the installation of one or more used oil burners to reduce the cost of sending the used oil off site and to reduce the cost of heating your facility in the winter.
