Dear Ms. Wyatt:

This letter serves as a notice of violation to inform you that we are missing the discharge monitoring reports listed on the attached sheet of paper. As a reminder hard copy self-monitoring report submissions are due on the 15th day of the following month and electronic submissions are due on the 20th day of the following month. Submit the missing reports **within 10 days** of the date of this letter. Even if no discharge occurs, as long as the permit is in place, a report must be submitted. Because of your recalcitrant attention to this issue, you are being referred to the Director of Ohio EPA for an enforcement action.

The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For those wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You can benefit economically, help preserve the environment, and improve your public image by implementing pollution prevention programs.
