Dear Mr. Damron:

On November 2, 2009, Rich Stewart and I conducted a complaint investigation to determine the validity of a complaint that was received by this office on October 26, 2009 and to determine your company's compliance with Ohio's hazardous waste laws and regulations, as found in the Ohio Revised Code and the Ohio Administrative Code (ORC and OAC, respectively). The complainant alleged that used oil was being disposed of on-site.

Based on the complaint investigation, we found the following violations of Ohio's hazardous waste regulations. In order to correct these violations, you must do the following and send me the required information ***within 30 days*** of your receipt of this letter:

- (1) **Used oil storage requirements for generators, OAC rule 375-279-22(C):** Containers and aboveground tanks used to store used oil at generator facilities shall be labeled or marked clearly.

During the inspection, the used oil containers were not labeled as required by this rule. To demonstrate compliance with this rule, these containers must be labeled appropriately and photographic documentation must be sent to this office for review.

- (2) **Used oil storage requirements for generators, OAC rule 375-279-22(D):** Upon detection of a release of used oil to the environment a generator shall clean up and manage properly the release used oil and other materials.

During the site visit, used oil contaminated soil was observed around leaking engine components and from a 55 gallon container behind the facility. As required by this rule, the used oil release must be cleaned up. To demonstrate compliance with this rule, photographic documentation must be submitted to Ohio EPA demonstrating that the contaminated soil has been cleaned up properly.
