Dear Mr. Smith:

On March 3, 2010, Melody Stewart and I inspected Severstal-Wheeling's Mingo Junction plant to determine its compliance with Ohio's hazardous waste laws and regulations, as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). This letter will identify and explain any violations we found, what you need to do to correct the violations, other general concerns/comments and pollution prevention opportunities we identified.

Based on this inspection, we discovered the following violations of hazardous waste regulations:

- (1) **OAC Rule 3745-52-11, Evaluation of Wastes:** Any person who generates a waste in the State of Ohio, as defined in rule 3745-51-02 of the Administrative Code, ...shall determine if that waste is a hazardous waste using the following method: (A) He shall first determine if the waste is excluded from regulation under rule 3745-51-04 of the Administrative Code; (B) He shall then determine if the waste is listed as a hazardous waste in rules 3745-51-30 to 3745-51-35 of the Administrative Code; and (C) For purposes of compliance with Chapter 3745-270 of the Administrative Code, or if the waste is not listed as a hazardous waste in rules 3745-51-30 to 3745-51-35 of the Administrative Code, the generator shall then determine whether the waste is identified in rules 3745-51-20 to 3745-51-24 of the Administrative Code by either: (1) Testing the waste according to the methods set forth in rules 3745-51-20 to 3745-51-24 of the Administrative Code, or according to an equivalent method approved by the Region V Administrator of U.S. EPA pursuant to 40 CFR 260.21; or (2) Applying knowledge of the hazardous characteristic of the waste in light of the materials or the process used.

Severstal-Wheeling, Inc. did not evaluate waste lab crucibles, generated in the analytical lab, to determine if they are hazardous wastes in violation of this rule. In order to abate this violation, Severstal-Wheeling, Inc. must evaluate these waste crucibles to determine if they are hazardous waste. To demonstrate compliance with this rule, please submit your findings to this office for review within **30 days** of receipt of this letter.

GENERAL COMMENTS

- (a) Ohio EPA encourages open communication regarding the status of all of Severstal Wheeling's plants. Of special concern, is if the situation would arise where any of the plants are completely shut-down for either a temporary basis or permanently (as defined by Ohio's Cessation of Regulated Operations laws and rules). It is important that all wastes and regulated substances be managed correctly prior to either a temporary or permanent shut-down.

During the inspection, a satellite drum, approximately 1/3 full of EAF baghouse dust (K061 hazardous waste) was present in the baghouse dust building. Ohio EPA recommends that all wastes in satellite containers be managed off-site when your facility is temporarily idled. All wastes must be managed appropriately if it is determined that a specific process will no longer be operated.

REMARKS - GENERAL INFORMATION

General Process Information:

Severstal-Wheeling Steel's Mingo Plant manufactures carbon steel in slabs from a Basic Oxygen Furnace (BOF) and a continuous caster. Rolls are produced from these slabs in the hot strip mill. A blast furnace is also operated producing iron from iron ore. In November, 2004, an electric arc furnace (EAF) began operation. A baghouse collection system is operated to capture air releases from the EAF and generates EAF dust (K061 hazardous waste). This dust is conveyed by a pneumatic pipeline to a railcar loading building adjacent to the baghouse building. Other operations include a locomotive shop, tractor shop, electrical shop, a carpenter shop, wastewater treatment facilities, a process water plant and a boiler house.

A coke oven gas line runs from a coke plant just across the river in West Virginia to the North plant and then to the Mingo plant and provides coke oven gas fuel to a Co-gen plant located on the Mingo plant site. Coke oven gas condensate is collected and returned to the coke plant. Three types of slag (BOF, BF, and Desulfurization slag) are produced and managed on-site by Olympic Mill Services located at the south end of the plant.

Regulatory/Enforcement History:

The last site-wide inspection by Ohio EPA-DHWM was performed in April, 2006.
