Dear Mr. Dunn:

On January 10, 2011, Scott Bergreen, and I performed a compliance inspection of your company (Dunn Trucking) to determine its compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

Based on our observations and review of facility documentation during this inspection, we found the following violations of the hazardous waste regulations. **Please provide the requested information within thirty days of the date of this letter:**

(1) Hazardous waste determination, OAC rule 3745-52-11:

Any person who generates a waste, as defined in rule 3745-51-02 of the Administrative Code, must determine if that waste is a hazardous waste using the following method: (A) He should first determine if the waste is excluded from regulation under rule 3745-51-04 of the Administrative Code. (B) He must then determine if the waste is listed as a hazardous waste in rules. (C) For purposes of compliance with Chapter 3745-270 of the Administrative Code, or if the waste is not listed as a hazardous waste in rules 3745-51-30 to 3745-51-35 of the Administrative Code, the generator must then determine whether the waste is identified in rules 3745-51-20 to 3745-51-24 of the Administrative Code by either: (1) Testing the waste according to the methods set forth in rules 3745-51-20 to 3745-51-24 of the Administrative Code, or according to an equivalent method approved by the Region V Administrator of U.S. EPA pursuant to 40 CFR 260.21; or (2) Applying knowledge of the hazardous characteristic of the waste in light of the materials or the processes used.

At the time of the inspection, Dunn Trucking had not adequately determined whether the painting waste solvents generated in the garage are hazardous wastes. Based on our telephone conversation of January 12, 2011, I understand that based on generator knowledge, you consider them to be hazardous waste, waste codes D001, D035 and F001. Therefore, you have returned to compliance with this regulation. Please see comment below regarding the management and disposal of this waste.

- (2) **Used oil storage requirements for generators, OAC rule 3745-279-22(C):**
Paragraph (C): Containers and aboveground tanks used to store used oil at generator facilities shall be marked clearly with the words "Used Oil."

During the inspection, we observed that your approximately 300-gallon and 2,500-gallon used oil tanks (one inside and one behind the shop, respectively) were not labeled "Used Oil". You marked these tanks appropriately during the inspection, therefore, you have returned to compliance with this regulation.

Other compliance issues:

- (a) During the inspection, we observed several small containers of paint waste in the garage. As we discussed, this waste is very volatile and flammable and this waste should be collected in to one container of drum which is kept closed. This will help protect your personnel from needlessly breathing in the vapors and control a potential fire hazard. This will also show that you are not illegally treating the waste by allowing it to evaporate. Additionally, you may want to mark the drum in some manner to ensure employees know what material should be placed into the container and that it is very flammable. **Please provide** a photograph showing that you have collected this waste into a closed container.
- (b) Also during the inspection, we observed five drums behind your garage that were not labeled and appeared to contain used oil in them. **Please provide** photographs showing that these drums have been labeled, the contents placed into your used oil tanks, or state what they contain if they do not in fact contain used oil.
- (c) When you need to dispose of the painting waste (under Ohio's regulations, you cannot store more than five, fifty-five gallon drums of hazardous waste), you will have to have a hazardous waste transporter collect the waste for proper disposal. You will need to keep the receipts for disposal to show that you are complying with these regulations.

You have abated all violations cited during the January 10, 2011 inspection, please provide the photographs requested above. I have included factsheets on hazardous waste and used oil with this letter for your use.
