Dear Mr. Hill:

On October 14, 2010, I performed an inspection of your company to determine its compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

Based on our observations, we observed some spillage of used oil on soils around your used oil tank, therefore, your company is in violation of the following hazardous waste regulation, please provide the documentation requested below within thirty days of the date of this letter:

- (1) **Used oil storage requirements for generators, OAC Rule 3745-279-22(D):** Upon detection of a release of used oil... a generator shall perform the following cleanup steps: (1) stop the release; (2) contain the released used oil; (3) clean up and properly manage the released used oil and other materials; and (4) if necessary, to prevent future releases, repair or replace any leaking used oil storage containers or tanks prior to returning them to service.

The used oil-contaminated soil around the used oil tank must be dug up and disposed of at a permitted solid waste landfill. To demonstrate compliance with this rule, please provide photographs showing this area once the soil has been removed and of the excavated soil placed into your solid waste dumpster.

Other issues:

As we discussed, you must keep and have available for review receipts from your used oil transporter to document that you use a transporter with an EPA Identification Number. Please retain this documentation for future inspections.

I have attached the checklists I used to evaluate your company and a factsheet on used oil management to this letter for your use.
