Dear Mr. Rodgers:

On November 19, 2009, Ohio EPA received a complaint alleging that used oil has been improperly stored on your property and is being released to soil. On December 2, 2009, I performed a complaint investigation of your property to determine the validity of the complaint. I also determined your facility's compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

Based on the observations made during the investigation, Ohio EPA has determined that your facility is in violation of the following used oil regulation; please provide the requested documentation within 30 days of the date of this letter:

- (1) **Used oil storage requirements for generators, OAC rule 3745-279-22(C):**
Paragraph (C): Containers and aboveground tanks used to store used oil at generator facilities shall be marked clearly with the words "Used Oil."

During the inspection, we observed that a 200 gallon storage tank of used oil in the shop, and several drums outside the shop, were not labeled "Used Oil". Please provide photographs of this tank and these containers of used oil once they've been labeled "used oil".

Other Issues:

I also observed a minor amount of leakage of used oil from a drum. This soil should be cleaned up and disposed at a permitted solid waste landfill and the use of any leaking containers should cease immediately.
