Dear Ms. Schmelzer:

On July 30, 2009, Jim Sferra and I performed a compliance inspection of your facility located on Wesley Chapel Rd, Somerset, Perry County, to determine its compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This letter will explain the hazardous waste violations we found and what you need to do to correct these violations.

Based on this inspection, Schmelzer industries is in violation of the following hazardous waste regulations:

- (1) **OAC Rule 3745-279-22(C), Used oil storage requirements for generators:** Containers and aboveground tanks used to store used oil at generator facilities shall be labeled or marked clearly with the words, "**Used Oil.**"

The Used oil container (55-gallon drums) was not labeled with the words "Used Oil", in violation of this rule. This violation was corrected during the inspection. Therefore, Schmelzer Industries has adequately demonstrated compliance with this rule.

GENERAL COMMENT

- (a) During the inspection, we discussed with you corrective action obligations for sites state-wide that at one time in their past operating history were cited for operating an illegal hazardous waste treatment, storage, or disposal facility, thereby, causing them to be eligible for corrective action at their facility. Thank you for taking the time to meet with us regarding this topic. Ohio EPA will address this issue with you under separate correspondence.

- (b) Used oil generated at your site must be either analyzed to determine if it is considered "on-spec" oil prior to giving away or selling for burning in a space heater, or the used oil can be transported off-site to an approved oil collection facility (see <http://www.epa.state.oh.us/dhwm/pdf/UsedOilSpaceHeaterBusiness.pdf> for more information on burning used oil in a space heater.) As we mentioned during the inspection, if Schmelzer Industries decides to have the used oil analyzed to determine if it is "on-spec" oil, you may request that the burner pay for analytical costs.
- (c) Ohio EPA recommends that Schmelzer Industries evaluate the placement of a berm at the entrance to the product storage/waste storage shed. This would help prevent the migration of any spilled liquid, in the event of an accidental leak or spill.

As we discussed during the inspection, you may be able to reduce the waste your facility generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your facility generates, you may be able to reduce treatment and disposal costs, and you may possibly reduce your regulatory requirements. The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You may benefit economically, help preserve the environment, and improve your public image by implementing pollution prevention programs. General Process Information:

Schmelzer Industries produces fiberglass "veil" used in other products to provide strength (e.g. reinforced plastics). The process is called the "Modigliani Process" and consists of running thin glass fibers onto a large spinning drum, where a smooth, fabric mat or veil is produced and a resin is sprayed on to bind the glass. Different binders are used and different mats are produced to meet customer needs. Products are called: "Pearlveil", "curveil", "Flexiveil", "pultrusion veil" and "firmat"

Schmelzer Industries sells to a variety of distributors or direct to customers. The facility consists of a large production building/factory with an attached office area. An outside storage yard and storage buildings are also on-site.

Regulatory/Enforcement History (if applicable): Schmelzer Industries was last inspected on February 13, 2001.
