Dear Mr. Welsh:

Thank you for accompanying Pete Thompson, Ben Reed and me during our January 20, 2010 inspection of your facility located at 2555 Adcock Road north of Junction City. Pete Thompson is with Ohio EPA's Division of Solid and Infectious Waste (DSIWM), Ben Reed is with Ohio EPA's Division of Drinking and Groundwater (DDAGW) and I represented Ohio EPA's Division of Hazardous Waste Management. Our site visit was in response to a complaint received by our office alleging that auto salvage operations at your business were potentially threatening drinking water wells in the area. During our site visit, we also conducted an inspection of your business to determine its compliance with Ohio's hazardous waste and solid waste laws and regulations as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This letter will explain any violations we found and what you need to do to correct the violations.

Based on this inspection, you are in violation of the following hazardous waste regulations:

- (1) **OAC Rule 3745-279-22(C), Used oil storage requirements for generators:** Containers and aboveground tanks used to store used oil at generator facilities shall be labeled or marked clearly with the words, "Used Oil."

**The poly used oil tank located across the road in your storage/maintenance building was not labeled with the words "Used Oil" in violation of this rule. This violation was corrected during the inspection, therefore, Franks Used Auto Parts has adequately demonstrated compliance with this rule.**

An inspection of your scrap tire management practices was also conducted during our January 20, 2010 investigation. You advised Pete Thompson that you use Campbell Scrap Tire to haul your scrap tires for proper disposal. Please be advised that all scrap tires must be stored in a manner to control mosquitoes. Specifically,

**OAC Rule 3745-27-60 (C)**- Anyone storing scrap tires shall maintain mosquito control as follows:

- (1) One or more of the following shall be done to control mosquitoes:
  - (a) Remove liquids from scrap tires within twenty-four hours of accepting the scrap tires.
  - (b) Store scrap tires such that water does not accumulate in scrap tires or containers. Tires shall be kept free of water at all times.
  - (c) Within twenty-four hours of accepting scrap tires containing liquid, arrange for the application of a pesticide or larvicide, which is registered for use as mosquito control by the Ohio department of agriculture.
- (2) Maintain mosquito control by keeping all tires dry or by continuing applications of a pesticide or larvicide to all scrap tires stored outdoors at no greater than thirty-day intervals or as recommended by the manufacturer or formulator.
- (3) Maintain mosquito control records at the premises indicating the name, type, amount used per tire, and EPA registration number of the pesticide or larvicide, the date and time of the application, and the name of the person who applied the pesticide or larvicide. The property owner or the owner or operator of the premises shall make the mosquito control records available for inspection by the director or the health commissioner during normal operating hours. The owner or operator shall retain copies of mosquito control records for a minimum period of three years.

#### **GENERAL COMMENT**

- (a) During the inspection, we discussed burning used oil in a space heater. Please be advised that in accordance with Ohio Administrative Code 3745-279-72, you cannot give away or sell used oil to be burned for energy recovery unless it has first been tested to determine if it meets the fuel specifications of OAC 3745-279-11. However, you can burn used oil for heating at your business without testing it as long as you meet the conditions outlined in the enclosed used oil fact sheet titled "Burning Used Oil in a Space Heater."

If you find ways to recycle, reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs and, you may possibly reduce your regulatory requirements. The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You may benefit economically, help preserve the environment, and improve your public image by implementing pollution prevention programs.
