Dear Mr. Atwood:

On January 20, 2010, Ohio EPA inspected Perfection Plus of Chillicothe, Ohio to determine compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Perfection Plus was represented by you.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations, you must do the following and send me the following **within 30 days** of the date of this letter.

- (1) **OAC Rule 3745-279-22(c), Used Oil Storage Requirements for Generators:**
Containers of used oil must be labeled with the words "Used Oil".

Nineteen five-gallon buckets of used oil located behind your shop and in the storage room were not properly labeled. In order to abate this violation, you must immediately label the drums with the words "used oil" and submit photographs to me at this office. Preferably, immediately send this used oil offsite for recycling to a reputable recycler and submit documentation (copies of receipts) that this has been done. In the future, all drums or containers of used oil must be properly labeled and sent offsite to a reputable used oil recycler that has a USEPA ID number. If you need a list of used oil recyclers, please contact me.

GENERAL COMMENTS

- (a) Perfection Plus is a conditionally exempt small quantity generator of hazardous waste that has accumulated the following drums of hazardous waste paint thinner (F003/F005 hazardous waste) for at least four years in a small storage room which is located adjacent to the main building but accessed from outside:

1. One red 100-gallon container which is approximately 1/3-1/2 full;
2. One blue 55-gallon drum that appears to be full; and
3. One red 55-gallon drum that appears to be full.

In addition to the above list, a partially full drum of paint thinner sludge (F003/F005) is located in the shop next to the solvent still, and a full 55-gallon drum of dried still bottoms (F003/F005) is accumulating in the shop area next to the solvent still. Also, because this drum is full, there are five or six small clear plastic bags of dried still bottoms accumulating on top of the drum.

Based on the above, Perfection Plus is at or beyond the five drum (275 gallon or 2,200 lb) limit to the amount of hazardous waste that can be accumulated before your company is subject to regulations as a hazardous waste storage facility, which would require a hazardous waste permit as well as numerous other requirements. Therefore, Perfection Plus must take immediate steps to manifest this waste offsite to a permitted hazardous waste treatment, storage or disposal (TSD) company. Information on how to do this was sent to you in an email dated January 21, 2010 which is attached to this letter for reference. Upon removal of these wastes by a TSD, Perfection Plus should submit copies of the paperwork to me at this office as documentation that this has been done. Please note that the paperwork must describe the exact volume and/or weight of hazardous waste that was sent offsite. Depending on the volumes or weight of the waste that was accumulated onsite, additional violations may be forthcoming.

Approximately 100 gallons of used oil and several drums of spent paint thinner (F003/F005) were stored onsite behind the building and in a small storage room accessed from the outside.
