Dear Mr. Bivens:

On August 4, 2009, Fred Snell and I visited your facility located at 6587 State Route 104, McDermott, in response to a complaint alleging that automotive fluids were being illegally stored and illegal dumping was occurring at the site. We did not observe illegal storage of auto fluids or evidence of illegal dumping while at your facility. During our visit, we also performed a hazardous waste compliance inspection of your facility to determine its compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This letter will explain the hazardous waste violations we found and what you need to do to correct these violations.

Based on this inspection, JanJos Enterprises, LLC is in violation of the following hazardous waste regulations:

- (1) **OAC Rule 3745-279-22(C), Used oil storage requirements for generators:** Containers and aboveground tanks used to store used oil at generator facilities shall be labeled or marked clearly with the words, "**Used Oil.**"

The Used oil tank located behind your building was not labeled with the words "Used Oil", in violation of this rule. This violation was corrected during the inspection. Therefore, JanJos Enterprises, LLC has adequately demonstrated compliance with this rule.

As we discussed during the inspection, you may be able to reduce the waste your facility generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your facility generates you may be able to reduce treatment and disposal costs, and you may possibly reduce your regulatory requirements. The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You may benefit economically,
