Dear Mr. Depue:

On October 30, 2009, I conducted a compliance evaluation inspection at Broughton Foods located at 1701 Greene Street in Marietta to determine compliance with Ohio's hazardous waste laws and regulations as found in the Ohio Revised Code (ORC) and the Ohio Administrative Code (OAC). During the inspection, I helped Broughton Foods identify ways to prevent pollution by reducing waste. This letter will explain the violations I found and what you need to do to correct the violations.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations, you must do the following and send me the required information **within 30 days** of your receipt of this letter:

(1) OAC Rule 3745-279-22(C), Used Oil Storage Requirements for Generators:

Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, one 55-gallon drum of used oil was not labeled "used oil", in violation of this rule. To abate this violation, Broughton Foods personnel labeled the drum during the inspection to return to compliance. No further action is necessary.

(2) OAC Rule 3745-273-13(D)(1), Waste Management - Standards for Small Quantity Handlers of Universal Waste:

A small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

Spent fluorescent bulbs were in a box in the maintenance department; however, the box was not closed, in violation of this rule. Broughton Foods must make sure all containers of fluorescent bulbs are properly closed and must submit photographs to Ohio EPA documenting that this rule is being met.

(3) OAC Rule 3745-273-14(E), Labeling/Marking - Standards for Small Quantity Handlers of Universal Waste:

Each lamp or a container or package in which such lamps are contained must be labeled or marked clearly with one of the following phrases: "Universal Waste-Lamp(s)," or "Waste Lamp(s)," or "Used Lamp(s)."

The box of spent fluorescent bulbs in the maintenance department was not labeled properly, in violation of this rule. Broughton Foods must make sure all containers of fluorescent bulbs are properly labeled and must submit photographs to Ohio EPA documenting that this rule is being met.

GENERAL COMMENTS

- (a) For your information, I have enclosed a fact sheet regarding fluorescent bulbs. As we discussed, fluorescent bulbs are a universal waste and must be managed under the universal waste rules in OAC 3745-273.

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce, or altogether eliminate the amount of waste that your company generates, you may be able to reduce treatment and disposal costs, and you may possibly reduce your regulatory requirements. The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You may benefit economically, help preserve the environment, and improve your public image by implementing pollution prevention programs. REMARKS-GENERAL INFORMATION

General Process Information:

Broughton Foods produces a variety of dairy and nondairy foods at its plant on State Route 26 outside Marietta, including milk, cottage cheese, sour cream, and soft serve ice cream. Broughton distributes their products in Ohio, West Virginia, Kentucky, Virginia, Maryland, and some products in Tennessee. The plant uses various cleaners and sanitizers which are used for cleaning equipment, etc.; spent cleaning solutions are then discharged to the city of Marietta sewage treatment plant. Broughton also uses boiler treatment chemicals in their normal operations. A tank farm outside the boiler room stores bulk chemicals such as acids, chlorinated cleaners, etc. Broughton's fleet of trucks are maintained off-site at Penske in Parkersburg, West Virginia. Most of the used oil generated at Broughton comes from the ammonia machines, homogenizers, and various hydraulic systems.

Regulatory/Enforcement History:

Broughton Foods is a Conditionally Exempt Small Quantity Generator. The last compliance evaluation inspection was conducted at Broughton Foods on August 11, 1998. No violations were found during that inspection.
