Dear Mr. Jones:

On July 20, 2011, Ohio EPA received a call from you stating that you were aware that Liberty Tire Monofill must submit a ten year design demonstration ten years after the date of the initial permit to install. You also noted that you were aware that Liberty Tire Monofill received a permit on February 2, 2001, and that the ten year anniversary has passed.

Failure to submit a ten year design demonstration upon the tenth anniversary of the initial permit is a violation of the following:

**Ohio Administrative Code (OAC) Rule 3745-27-75(N)**: which states, in part, "...Upon the tenth anniversary of the effective date of the initial permit to install issued to the owner or operator of a scrap tire monofill facility pursuant to Chapter 3734. of the Revised Code and each tenth anniversary thereafter, the owner or operator shall submit to Ohio EPA an analysis demonstrating that the design of the unconstructed portions of the facility continues to be consistent with the design standards established in the current version of the rule 37345-27-72 of the Administrative Code..."

Nothing in this letter shall be construed to authorize any waiver from the requirements of any applicable state or federal laws or regulations. This letter shall not be interpreted to release the owner or operator of Liberty Tire Services of Ohio, Liberty Tire Monofill, or others, from responsibility under Chapters 3704., 3714., 3734., or 6111. of the Ohio Revised Code or under the Federal Clean Water or Comprehensive Environmental Response, Compensation and Liability Acts remedying conditions resulting from any release of contaminants to the environment.
